5 CONCERNS RAISED BY RAKESHBHAI RAVJEE

Anielbhai reported that due to various circumstances his next meeting with ABSA to pursue our case of recovering the stolen money will only take place around 18 November. investigation has also revealed evidence of the movement of money between accounts taking place prior to 2008, although it was unclear whether these movements constituted attempts at fraud. Letters have been sent by Tayfin to the previous trustees requesting them to provide certain information in respect to their roles as trustees. Rameshbhai expressed concern that because of the legalistic nature of these letters, some trustees were viewing them in a negative light. It was agreed that Prakashbhai will request a meeting with these individuals so as to clarify any Prakashbhai concerns they might have.
