WELCOME AND PRAYER

The meeting commenced at 7:40 with a prayer and welcome to all present.

AMENDMENT TO AGENDA

The president requested that the agenda for the meeting be cancelled and that instead the committee discuss the article that appeared in the Laudium Sun on Friday 3 September. This was agreed to.

ADVERSE PUBLICITY IN LAUDIUM SUN

The President explained that in his opinion, the article published in the Laudium Sun

brought the officials and Samaj into disrepute. He pointed out that strangely the article

largely reflected the minutes sent out on 19 August by Nipun Jeeva on behalf of the

ex-members of the education committee, thus causing suspicion. He further pointed

out that in his opinion it was cowardly for certain members of our community to

anonymously give incorrect and distorted information to the press, thus making it

difficult to pinpoint responsibility. He expressed his disgust that some members of our

community would stoop to such a level.

The members discussed a draft response in which these allegations would be

addressed. However, it was argued that publishing this would mean that Samaj

officials would be contributing towards further harming the image and dignity of the

community. In addition, members felt that it was not in the best interest of the

community to air Samaj affairs in public. Consequently, it was agreed not to place a

rebuttal in the press but to address the matter through the internal structures of the

Samaj.
